RESOLVED; to approve as it is hereby approved Supplemental Budget No. 1 CY 2024 of Barangay Poblacion, this Municipality, amounting to Two Million Three Hundred Fifteen thousand Five Hundred Eighty Nine pesos and sixty two centavos (PHP 2,315,589.62);

RESOLVED FINALLY; that copies of this resolution be furnished to the Office of the Municipal Mayor, and to the Office of the Municipal Budget Officer, both in this municipality for information and guidance;
