WHEREAS; Barangay Poblacion, in this municipality, is one of the recipent of KALAHI PROJECT which is called Development of Public Relocation Site;

WHEREAS; one of the prevailing problem of Barangay Poblacion is the proper area intended for the said project;

WHEREAS; this August Body thought of a noble idea that granting one half hectare(.5 hectare) of land owned by the Local Government Unit of Payao to the Barangay Government of Poblacion, greatly contributes for the realization of the project and improved livelihood and lifestyle of a displaced families;
